The tender will be received between 10 A.M. to 02:00 PM on 08.06.2016 and opened at 3 P.M. on the same day before the tenderer or their authorized representative.

## TERMS AND CONDITIONS OF LEASE OF HOARDING SPACE

The lease period shall be for three years w.e.f 2016-17 (Part) upto 31<sup>st</sup> March,2017 only as mentioned in schedule –A.

The completed tenders are required to be submitted in sealed envelope super scribing on the envelope indicating as follows:

a) To,

Guwahati Municipal Corporation,
Panbazar, Guwahati-781001.

b) "Tender for lease of sites for construction of Hoardings at ...... under Guwahati Municipal Corporation".

The Envelope shall indicate the name and address of the tenderer, Incomplete, late or tenders received without Earnest Money deposit (For short, EMD) and the details as asked for the tender documents will not be considered.

2. The tender must be accompanied by a non-refundable tender fee of Rs.1000/-(Rupees one thousand) only and 10% (Ten percent) of bid value as earnest money for General category persons and 5% (Five percent) of bid value as earnest money for S.C. and S.T. tenderer.

The earnest money shall be deposited by way of a demand draft drawn in favour of **The Commissioner**, **GMC** payable at Guwahati.

- 3. The following documents are required to be submitted along with the tender :
  - a) A photocopy of the Photo id proof (e.g. Pan Card/Voter ID/Driving License) of the bidder/partner/authorized signatory of the company as the case may be.
  - b) Trade license obtained from the G.M.C
  - c) If any bid appear to be unreasonably low or high, reckless and highly disproportionate then the Commissioner GMC shall have every right to reject such offer.
- 4. Rate for each site should be quoted separately.
- 5. The Rate should be quoted on per annum basis. For the year 2016-17 the amount payable will be calculated on prorate basis.
- 6) The rate should be quoted in figure as well as in words. If there is any discrepancy between the two then the rate quoted in words will be considered.
- 7) All corrections in the tender papers shall be attested by the dated initials of the tenderer.
- 6. There is no estimated / base value for sites. The tenderer may quote at his / her own quoted rate after proper inspection of the site.
- 7. The lengths the hoarding sites shown in the list are approximate. Bidders are requested to make physical survey of the sites for their satisfaction before bidding.
- 8. If the bidder wants to erect lit hoardings then NOC will be issued by Guwahati Municipal Corporation. The bidders will have to obtain connection from APDCL in his name.
- 9. NOC from other agencies such as APWD, Police ,if necessary, wil have to be obtained by the bidder.
- 10 All precautions should be taken by the bidder regarding stability, safety and security of the hoardings ,so that no damage is caused to any person, public or private property.

- 11. Selected bidder will have to deposit the lease amount for the year 2016-17 within 3(Three) days of receipt of intimation from the undersigned. On default, the bidder will be disqualified and his earnest money shall be forfeited. In such a situation, the next highest bidder shall stand qualified.
- 12. For the year 2017-18 and 2018-19, the lease amount will have to be paid within 15<sup>th</sup> March of the preceding year i.e. by 15.03.2017 and 15.03.2018 respectively.
- 13. The successful bidder will have to pay Hoarding tax to GMC as per the prevailing rates.
- 14. Defaulters of Guwahati Municipal Corporation will not be entertained.
- 15. No person, firm, co-operative society or company will be allowed to participate in the tender process who/which was either convicted by any Court of law at any point of time or blacklisted by the Corporation in connection with any contract or has failed to execute any work entrusted by the Corporation.
- 16. It would be obligatory on the part of the tenderers to sign the tender documents on all relevant pages and for all component parts thereof.
- 17. The lessee shall adhere to any reasonable new instructions issued from time to time by the GMC .
- 18. The violation of any of the terms and conditions shall lead to termination of the lease agreement with the lessee.
