DETAILED BID NOTICE

Separate sealed bids are invited from reputed firm / Contractor / supplier etc. for supply of following types of Poclain on hired basis to Guwahati Municipal Corporation, Guwahati. Bids will be received up to 2:00 P:M of 05 / 10 /2016 at Head Office, Guwahati Municipal Corporation, Panbazar, Guwahati-1 and the same will be opened on the same date and venue at 2.30 PM in presence of the bidder or their authorized representative who would like to be present.

Terms & conditions:

- (1) In case of downloaded document the bid document fee for Rs. 1000.00 (Rupees One Thousand) only, have to be submitted either in cash, (to be deposited in Cash Branch, GMC, receipt of which to be enclosed with the bid at the time of submission) or Bank Draft pledged in the name of Commissioner, Guwahati Municipal Corporation.
- (2) Every bid must be accompanied with an Earnest money of Rs 15,000.00 (Rupees Fifteen Thousand) Only in the form of Demand Draft / Banker's Cheque of any scheduled bank, duly pledged in the name of the Commissioner, Guwahati Municipal Corporation.
- (3) The rate quoted will be valid for a period of 1 (one) year from the date of opening of the bid.
- (4) Machine will be hired as per requirement of Guwahati Municipal Corporation.
- (5) Rates to be quoted on monthly basis at a prescribed format at Rate Sheet including all taxes and duties for the category of machines which the bidder wants to provide or able to provide, separately, in the rate sheet provided with this documents.
- (6) Bid once submitted cannot be withdrawn without any valid reason.

- (7) Canvassing directly or indirectly in any form in connection with the bid strictly prohibited and offers submitted by anyone who resort canvassing are liable for rejection.
- (8) If the opening date of the bid falls on holiday or the office remains closed on the opening date, due to any reason, the bid will be opened on the next working day at the same time.
- (9) No extra condition other than NIT will be entertained. Conditional bid will be rejected outright.
- (10) Photocopy of PAN Card/VAT/Sales Tax Certificate must be submitted with the bid.
- (11) The name of work must be subscribed on the cover containing the bid.
- (12) The bidder must furnish their full postal address / contact numbers / eMail ID with the bid. All correspondence onwards will be made by ordinary post/eMail which will be assumed to be received by the addressee and no complain will be entertained on non-receipt of letter. Change of address should be intimated immediately.
- (13) Every page of the bid must be signed by the bidder and any correction must be initialed.
- (14) The rate should be quoted both in words and figures clearly and any correction must be initialed.
- (15) In case of any dispute the decision of Commissioner, G.M.C. will be final.
- (16) The authority reserves the right to reject all or any bid without assigning any reason thereof and does not bind itself to accept the highest rate.

Special condition

- 1) A formal agreement with Commissioner, GMC is to be signed after selection of the bidder.
- Bidder must furnish the photocopy of sales certificate (Form 21 & 22) and Insurance paper
 of the machine along with the Driving License of the operator with the bid.
- Machines in tip-top condition with driver / operator must be placed at dumping yard/Work Place for duty.
- 4) The machine must perform minimum 8 hours duty in a day. Working of the Machine should be started from 8.00 AM onwards or as directed by the Engineer concern. The machine may be engaged up to 16 hours in a day. However if situation demands operation of machine may be required at night time also.
- 5) If the machines become non-operational due to any mechanical defect, it must be repaired immediately or a replacement must be provided. Availability of machine for one month must be maintained minimum 200 hours (25 X 8). For any short fall of working hour due to mechanical defect (less than 200 hours in a month) penalty will be imposed @ Rs. 2,000/-per hour.

- 6) All responsibility of the machines including accident or breakdown during hiring period will be solely on the bidder/machine provider. All cost towards the machines repair etc. will be borne by the bidder/machine provider.
- 7) The machine must have a Log book for recording the day to day performance of the allotted 8 hrs duty, then the log book must be signed by the engineer concern or authorized supervisor daily.
- 8) In case of rate without fuel, GMC will provide only fuel as per 8 hour duty. Other lubes/fluid etc. are the responsibility of bidder/machine provider, Rate to be quoted accordingly.
- Provided/engaged machine cannot be withdrawn by the bidder/machine provider without 30 days prior intimation to the department.
- 10) Machines will be used mainly for dressing of dumping yard, drain de-silting etc. On requirement the same may be used in other purpose also.
- 11) The bill for the hire charges shall have to be submitted monthly basis at the Garage Branch, GMC for payment along with the log book duly signed by the Engineer concern.
- 12) GMC may terminate the contract at any moment if the performance of the machine is not satisfactory or any other.
