Notice Inviting Quotation for Delivery of the Property Tax Bills at home mentioned in the Annexure of this NIQ.

With reference to the aforementioned subject the Guwahati Municipal Corporation invites quotation from all the eligible agencies/firms for **delivery of the property tax bills at home.**

The eligibility criteria of service provider are as under:-

- 1. The service provider must possess their Registration No., Trade Licence and PAN No.
- 2. The Average annual turnover of the vendor should be more than 1 Lakhs for the last three years.

Kindly attach the documentary proof of aforementioned eligibility criteria along with the quotations. The commercials for the referred work should be filled in the format as per Annexure.

Terms & Conditions

- 1. The Quotations must be addressed to the Commissioner, GMC in the Bidder's letter pad.
- 2. Name and Address of the Bidder should be clearly mentioned.
- 3. Intending Bidder should mention their TIN No., Trade Licence and PAN No. Submitting self attested photocopies of the same thereof. Else it will be a cause to disqualify the quotation.
- 4. The Bidder shall quote the amount including all the prevailing applicable taxes.
- 5. Bidder has to quote the rate as per prescribed format in Annexure III.
- 6. The envelope should be super scribed with "Quotation for Delivery of Property Tax Bills at Home".
- 7. The Quotations shall be valid for 12 (Twelve) months from the last date of submission.
- 8. Bidder has to submit a non refundable bid processing fee of Rs. 1000.00 /- (Rupees one thousand only) in form of Demand Draft payable in favour of Commissioner, Guwahati Municipal Corporation in any nationalized bank of India.
- 9. EMD of Rs. 5,000.00 /- (Rupees five thousand only) has to be submitted in the form of Demand draft payable in favour of Commissioner, Guwahati Municipal Corporation in any nationalized bank of India.
- 10. The contract will be initially for one year and may be renewed based on the satisfactory performance which will be decided by the GMC.
- 11. The result after scrutiny of quotation will be communicated to Qualified Bidder.
- 12. The Bidder quoting the lowest rate for the work will be declared successful.
- 13. The selected Bidder will be issued a Letter of Intent (LoI).
- 14. TDS will be deducted from the payment of the selected Bidder.
- 15. The company should have a minimum average annual financial turnover of Rs. 1.00 Lakhs in each year for last three financial years. Copy of audited balance sheet or certificate from Auditor towards such financial performance to be attached during the last three years duly certified by Chartered Accountant.
- 16. Experience of similar nature for minimum 1 year is preferable. Proof of such experience to be attached.
- 17. Presence of office in Guwahati is must. Proof to be attached.
- 18. The bidder should not have been blacklisted by Guwahati Municipal Corporation or any other ULBs or Government organisation in India. An Undertaking to this effect to be submitted at the time of submission of Quotation as per prescribed format in Annexure II.
- 19. No consortium will be entertained; only individual Firm/ Agency/ Company will be allowed to quote.
- 20. NIQ documents and its Annexure, each page duly stamped and signed by the authorized signatory to be submitted along with all the supportive documents and Ouotation.
- 21. Payment to the Bidder will be made against the delivered property tax bills only.
- 22. The bidder has to collect the House No, Mobile No, first line of address, Email Id etc. of the owner against the assessment Id.
- 23. The bidder has to submit the delivery report as per format given in Annexure IV to the concerned Deputy Commissioner in soft copy as well as hard copy.
- 24. Bill should be delivered within 3 months.

- 25. Penalty will be charged Rs.100.00/per bill for doing any unfair means instead of delivering the bill.
- 26. The bidder has to deliver 2 following pages to Citizen
 - a. Printed Bill (to be collected from GMC Office)
 - b. 1 Page of Demand Notice (Annexure V) and Guidelines on back side of demand notice. Demand Notice and Guidelines will be supplied by Bidder. Bidder has to fill the details in demand notice and signed by GMC Officer.
- 27. In case of any query, Interested Bidder may approach to the OSD, Project Management Cell Office during office hours.
- 28. The sealed quotation should be dropped in the tender box kept in the Chief Engineer branch, Office of the Commissioner, Guwahati Municipal Corporation, Panbazar, Guwahati-01
- 29. With 1 (One) month prior notice, GMC may terminate the contract without assigning any reason.
- 30. The Commissioner, GMC has the right to accept or reject any or all the quotations without assigning a reason thereof.
