**CORRIGENDUM.**

In partial modification to this office notice vide letter no GCS/PMC/717/16/1123 Dated :- 29/04/17 for Supply of 13 number trolley mounted bio-toilets to Guwahati Municipal Corporation (GMC) including maintenance during Ambubachi Mela, the following modifications are made in the RFP.

1) The format of technical evaluation is revised as follows :
