CORRIGENDUM

In partial modification to the Invitations for Bids issued vide this office no. GER/CE/1247/17/5 dated 05/05/2017; the following modifications have been made to the list of

- 1. The total Estimated amount for package no. C&D/D-II/A may be read as Rs. 27,00,300.00 instead of Rs. 34,03,000.00. The Bid Securities for General & SC/ST/OBC/UEE categories are Rs. 54,000.00 & Rs. 27000.00 respectively. Also the cost of bid document is Rs. 4000.00.
- 2. The Milanpur Roadside drain in ward no. 14 has been omitted from the package no. C&D/D-IV/A and the estimated amount for the said package may be read as Rs. 8,52,500.00 instead of Rs. 15,38,000.00. The Bid Security Amount for General is Rs. 17000.00 & for SC/ST/OBC/UEE is Rs. 8500.00. Also the cost of bid document is Rs. 2000.00.
- 3. The underground drain of Bishnupur Road & its bye lane in ward no. 15 has been deleted from the package no. C&D/D-IV/B instead of which the following drain has been considered - a. Arya College girls Hostel drain in ward no. 15 & 18. The total Estimated amount for the said package is Rs. 27,03,000.00 instead of

Rs. 22,77,000.00. Also The Bid Securities for General & SC/ST/OBC/UEE categories are Rs. 54,000.00 & Rs. 27000.00 respectively.

4. The Estimated Amount for the Package No. C&D/D-IV/C may be read as Rs. 12,73,500.00 instead of Rs. 10,14,000.00. The Bid Security Amount for General is Rs. 25500.00 & for SC/ST/OBC/UEE is Rs. 13000.00.

All other terms & conditions shall remain unchanged.
