Terms & Conditions

- 1. The Quotations must be addressed to the Commissioner, GMC in the Bidder's letter pad.
- 2. Name and Address of the Bidder should be clearly mentioned.
- 3. Intending Bidder should mention their PAN No. And GST No. etc. (as applicable) submitting self-attested photocopies of the same thereof. Else it will be a cause to disqualify the quotation. Firms/agency/company registered as MSME can submit Udyog Aadhaar.
- 4. All proposals submitted in response to the NIQ shall be accompanied by an EMD of Rs. 50,000.00 (Rs. Fifty Thousand) only in the form of Demand Draft in favor of "**The Commissioner, Guwahati Municipal Corporation**" payable at Guwahati. The EMD of the unsuccessful bidders would be returned after the acceptance of the letter of Intent (LoI) to the successful bidder.
- 5. The EMD of the successful bidder will be kept by GMC as performance bank guarantee at the time of issuing Letter of Intent (LoI).
- 6. The bidder quoting the Highest amount (H1) for the work will be declared the successful bidder and will be issued the LoI.
- 7. Bidder has to quote the rate as per prescribed format in **Annexure IV**.
- 8. The Quotations will be valid for 12 (Twelve) months from the last date of submission.
- 9. The Envelope should be super scribed with Quotation for "**Removal of illegal hoarding** with purchase of Scrap At quoted Price".
- 10. The result after scrutiny of quotation will be communicated to Qualified Bidder.
- 11. The Bidder shall be responsible for undertaking all civil/mechanical/electrical works related to the work.
- 12. The bidder has to provide their own vehicle, manpower, gas cutter etc that are required for removal of illegal hoarding as and when required by GMC
- 13. The selected bidder has to complete the work assigned within the timeline set by GMC.
- 14. Any Conditions of the bidder sent along with NIQ, if any, shall not be binding on GMC.
- 15. No payment will be made to bidder by GMC except scrap which will be bought by bidder at quoted price.
- 16. Difference in market price and quoted price of scrap can be treated as cost of removal of illegal hoarding.
- 17. The service shall be provided in 24 hours & 7 days in week as desired by GMC.
- 18. As and when required by GMC, the selected Bidder will have to provide onsite support to GMC stuff.
- 19. Preference will be given to bidders who are from Guwahati. Proof to be attached.
- 20. The bidder should not have been blacklisted by any ULBs in Assam, Central & State or Government organization in India.
- 21. Consortium of maximum two firms/agency/company will be allowed.
- 22. All Quotation must be submitted, duly signed by the Bidder.
- 23. The bidder should submit technical quote (Annexure-II) and financial quote (Annexure-IV) separately in two separate envelopes along with relevant documents and demand drafts for EMD. The envelopes for technical quote (Annexure-II) and financial quote (Annexure-IV), the Demand Drafts, Covering Letter (Annexure-I), Self Certificate (Annexure III) and a copy of the bid document duly Seal and signed by the authorized signatory of the bidder in each page are to be put together in an outer envelope which is to be submitted on or before the last date of submission.
- 24. In case of any query, Interested Bidder may approach to the Hoarding Branch, Lakhtokia, GMC, Guwahati till 26/07/2021 till 2:00 PM.
- 25. The sealed quotation should be dropped in the tender box kept in the Conference hall, Office of the commissioner, Guwahati Municipal Corporation, Panbazar, Guwahati-01.

- 26. GMC may terminate the work order without assigning any reason.
- 27. The bidder will work under strict supervision of GMC official under GMC area.
- 28. The bidder(s) must not be convicted by any court and there must not be any criminal case pending against him/them.
- 29. During the dismantling/removal process every care should be taken to prevent mishap. For any mishap the selected bidder or and his authorized representative will be responsible for any civil/criminal liability.
- 30. The bidder shall provide Safety Equipment and Personal Protection Gear to all workers in view of Covid 19 Pandemic.
- 31. The selected bidder will have to bear all direct/indirect/incidental cost with regards to execution of the work related with dismantling and removal of unauthorized Hoardings and sky signage along with structure including cost for travelling, halting, etc for their personnel for implementation and execution of the work at each location.
- 32. All scraps shall be carried to the Enforcement Branch for weighing purpose. Weighing machine will be provided by the Nazir,GMC. The record will be verified & signed by the Branch Officer on daily basis.
- 33. All calculations will be done on the basis of the rate quoted by the selected bidder.
- 34. The payment has to be made in the Hoarding Branch within 3 days from the date of weighing of the scraps.
- 35. In case of default payment by the selected bidder within 3 days, the work allotment will be given to the next successful bidder. EMD of the previous bidder will be forfeited.
- 36. The eviction process may be summarised as follows-
