

2. Sealed bid must be accompanied with Court fee stamp.
3. The Price quote/offered price must be inclusive of all taxes, duties, levies etc.
4. Transportation, lifting, handling and comprehensive removal of items within 7 days from date of acceptance of bid shall be the sole responsibility of Bidder. No resources of GMC shall be utilised.
5. The Earnest money may be adjusted with the bid price on acceptance of bid.
6. The bidder will have to deposit the accepted bid amount in total (no part payment) within a period of 48 hours from the date of acceptance of bid.
7. The bidder shall have to lift and vacate the site where the items are lying within 7 days from the date of acceptance of bid.
8. Delayed lifting may lead to a penalty of 0.5% per day beyond the allotted 7 days.
9. Bids must be submitted in a Single Sealed Envelope.
10. Most preferential bidder shall be the bidder quoting the Highest.
