3. The Technical Bids will be opened on **28/03/2024 at 1500 hrs.**
4. In the event of date of bid opening being a holiday, the activities will take place on the next working day.
5. Original copy of the following documents must be submitted before **14-00 hrs on the last date of bid-submission as notified** at the office chamber of the Executive Engineer, Water Works, Guwahati Municipal Corporation, Panbazar.
  - a. Original Power of Attorney for signing the BID for bidders other than individual

- bidders;
- b. BID Securities have to be submitted online.
6. A hard copy of the technical bid submitted online is to be submitted **on or before** 28/03/2024 **up to 1400 hrs** for evaluation purpose. For any discrepancy between the online bid and the hard copy of the bid, the online bid will govern and will be considered for evaluation.
