DETAILED INVITATION FOR BIDS (IFB) LOCAL COMPETITIVE BIDDING

- The Commissioner, Guwahati Municipal Corporation, Guwahati invites bids from registered Guwahati Municipal Corporation Contractors for the works as detailed below.
- Prices quoted should be net inclusive of all taxes, must be in Indian Rupees and shall remain valid for 90 (Ninety) days from the closing date of bid.
- 3. Details may be downloaded from the official website of GMC, www.gmc.assam.gov.in and www.gmcportal.in, with effect from 06/2020. Hard copies of the Bid Document will not be available for sale.
- 4. Bid must be accompanied by a security of the amount as specified in the Bid Document payable at Guwahati and drawn in favour of the Employer. Bid security will have to be in any of the form as specified in the bidding document and shall have to be valid for at least 45 days beyond the validity of bids. Bid must also accompany a non-refundable bid document fee as specified in the bidding documents in the form of Demand Draft/Banker's Cheque on any nationalized/schedule bank payable at Guwahati in favour of the Commissioner, Guwahati Municipal Corporation. Bids received without non-refundable document fee will be rejected.
- 5. Bid must be delivered to the tender box of the office of the Commissioner, Guwahati Municipal Corporation, Panbazar, Guwahati-781001 on or before 2.00 PM on 09 06/2020 and will be opened on the same date at 2.30 PM, in presence of the bidders who wish to attend or his authorized representative. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
- The Undersigned reserves the right to accept or reject any Bid, and to cancel the Bidding process and reject all Bids, at any time prior to the award of Contract, without thereby incurring any liability to the affected Bidder.
- The whole tendering and evaluation process will be scrutinized and finalized by the tender Evaluation Committee, GMC and the decision taken by the committee will be binding on the bids.
- Contractors whose work under GMC has been rescinded due to any reason or blacklisted by any
 other department or involved in legal litigation shall not be eligible for this bidding process.
