That if any conclusive evidence could be established by any aggrieved person or by the GMC authority which is contrary to any of the terms conditions and my declaration at para 2 above, the violation being committed either by my agent or employees, the Commissioner, GMC shall be at liberty to cancel, reject and terminate forthwith, as the case may be, the tender or the lease at any stage during the time of settlement or during the lease period. TERMS AND CONDITIONS OF LEASE OF PARKING PLACE FOR THE YEAR 2021-2022

1) The lease period shall be for 09 (nine) months only and would be effective from 01/07/2021 to 31/03/2022 in respect of the 52 (fifty two) parking places as mentioned in the re-tender notice.

The completed tenders are required to be submitted in A₄ size sealed

envelope super scribing on the envelope indicating as follows:

a) To,

Guwahati Municipal Corporation,
Panbazar, Guwahati-781001.

b) "Tender for settlement of parking place at under Guwahati Municipal Corporation".

The Envelope shall indicate the name and address of the bidder. Incomplete, late or tenders received without Earnest Money deposit (For short, EMD) and the details as asked for the tender documents will not be considered.

- 2) The tender must be accompanied by a non-refundable tender fee of Rs.1000/-(Rupees One Thousand) only by Demand Draft/ Banker's Cheque along with tender forms with copy of terms and conditions and the documents mention there (as mentioned in the re-tender notice). He is also requested to deposit 10% (Ten percent) of Estimate value as earnest money for General category persons and 5% (Five percent) of Estimate value as earnest money for S.C., S.T. and OBC bidder.
- 3) A photocopy of the Pan Card, Voter ID, Up to date Income Tax clearance certificate, Financial sound certificate, GMC Property Tax Receipt, the Trade licence obtained from the G.M.C. and GST registration certificate in favour of the bidder, should be enclosed with the tender document while submitting, else the tender will be rejected outright.
- 4) If any bids submitted for settlement of the parking places under the Guwahati Municipal Corporation appear to be unreasonably high, reckless and highly disproportionate, if there is probability or apprehension of indulgence of extortion activities to realize such settled value the Commissioner GMC shall have every right to reject such offer.
- 5) The bidders should quote in figure as well as in words the rate and amount tendered by them. All corrections in the tender papers shall be attested by the dated initials of the bidders.
- 6) Where the rate quoted by the bidder in figures and in words do not tally, the amount written in words shall be taken as correct. The rate should be quoted for 09 (nine) months only.
- 7) The distances shown in the list of city parking places are approximate. If any City Bus stand falls within the parking slot 15 meters from both sides of city bus stand shall be excluded from parking of vehicles. In case of notified Auto Stand, the net auto stand area has to be excluded from parking of vehicles by the lessee. Bidders are requested to make physical survey of the parking places for their satisfaction before bidding.

8) Selection Process:

 After scrutiny of the documents submitted by the bidders, the successful bidder will be intimated by giving a Lol (Letter of Intent) to him/her.

- b) After getting the LoI the selected bidder has to deposit 50% of the settled value as advance deposit within 48 hrs. from the receipt date.
- c) After receiving the above mentioned documents the bidder will be given a final order granting the lease of the parking. The balance 50% amount of settled value will have to be deposited by the bidder in 4 (four) equal installments the due date of which will be intimated in the aforesaid order.
- d) The selected bidder has to execute an agreement with the Commissioner, GMC within 10 (ten) days from the date of issue of the final order granting lease of parking otherwise the lease shall be invalid.
- e) On default, the bidder will be disqualified and his earnest money so deposited in the prescribed form shall be forfeited. In such a situation, the next highest bidder shall stand qualified for the next offer.
- f) If the lessee/bidder fails to pay any of the installments within the stipulated time as mentioned in the order granting lease of parking, 10% penal interest shall be charged against any such delayed payments. Further, if the lessee fails to pay installment within 3 (three) months, the lease would be terminated forthwith and the parking place will be taken over by GMC and earnest money and the advance payment so deposited shall be forfeited declaring the lessee as defaulter. Defaulting lessee shall be liable to be blacklisted and shall be prohibited from participating in any tender process of the Corporation in future. Any arrear due to the Corporation by the lessee, shall be recovered either under the provisions of the Chapter XX of the Guwahati Municipal Corporation Act, 1971 or under the Bengal Public demand recovery Act, 1913, or as the Commissioner may decide in this behalf.
- 9) On acceptance of any tender, the bidder shall be liable to pay any taxes as per Contract Act and the Corporation will not entertain any such claim whatsoever in this respect. The rate quoted by the bidder should be in the following format:

- 10) No concession regarding Bharat bandh or Assam bandh or local bandh or any such thing except for any pandemic situation will be entertained. In the particular case of pandemic situation the rate of concession amount will be calculated on per day basis proportionate to the quoted amount of the bidder.
- 11) In case of any delay for issuance of the final lease order, the adjustment will be made considering the issue date of the lease order as lease starting date. The total payable amount will be calculated starting from the issue date of the lease order up to the end date of the lease and this adjustment will be made during the last installment of the lease.
- 12) No person, firm, co-operative society or company will be allowed to participate in the tender process who/which was either convicted by any Court of law at any point of time or blacklisted by the Corporation in connection with any contract or held irresponsible in any, matters of the Corporation. The previous conduct or records of any such bidder, if any shall work out the basis for such purpose.
- 13) Any bidder who withdraws his tender after submission of the tender but before opening of the same for such modifications which are not acceptable to GMC, then the Commissioner, GMC without prejudice to any other right or remedy, will be at liberty to forfeit earnest money.
- 14)It would be obligatory on the part of the bidders to sign the tender documents on all relevant pages and for all component parts thereof.

- 15) The selected bidder shall collect caps and jackets from GMC on payment of Rs. 500/- per head in addition to 50% security deposit within 48 hrs. of the offer letter. The actual amount can be more or less depending upon the actual cost of products.
- 16) The settled bidder, to be later named as lessee, shall be entitled to levy parking fee as per the rate prescribed below and all collections are to be made through Android POS based ticketing system.

- 17)At the time of parking, a ticket for parking shall be issued to the owner / driver of the vehicle by the lessee where entry time and exit time of the vehicle should be clearly mentioned. The collectors present at the parking place should maintain the social distance as mandated by COVID 19 guidelines, wear mask, hand gloves and maintain proper hygienic condition at the parking slot, as a precautionary measure against the pandemic situation.
- 18) Excess demand of parking fee beyond the prescribed rate is strictly prohibited. Any complaint of charging excess money shall lead to institution of Criminal proceedings under law against the settled bidders and his agents and will result in cancellation of lease without assigning any reason thereof.
- 19) The lessee must not sub-let or use the parking place for any business/means other than parking, failing which result in termination of the lease without assigning any reason thereof.
- 20) The lessee shall maintain a register wherein registration no. of the vehicle and name of the person driving the vehicle shall be recorded.
- 21)The lessee shall use Digital Camera (CCTV cameras for flyovers and must check vehicles on entry with under vehicle search mirror and metal detector), and other necessary equipments required for implementation of this contract and take photographs of the persons driving the vehicle and keep records with him at the time of parking, date wise for at least last 7 (seven) days for verification by authorities, else action will be initiated as per law and tender will be cancelled forthwith.
- 22)The lessee shall maintain proper lighting of the entire parking space under the flyover in order to prevent any untoward incident.
- 23) The period of parking shall be confined from **8 A.M. to 10 P.M.** only. The lessee shall not operate any parking outside these hours.
- 24) Parking fees should not be levied on Govt. and GMC vehicles while on duty.
- 25) The Commissioner, GMC reserves the right to disqualify any tender/ terminate the lease without assigning any reason thereof.
- 26)In case of any eventualities, engagement holder is bound to produce related records, failing which he will invite punitive action as per law.
- 27) Municipal bins in and around the parking place are to be monitored closely by the lessee & the lessee shall inform NGO/GMC Engineers in case the bins are full.

- 28) The engagement holder or his employee should keep close liaison with concerned police stations and inform immediately if any suspicious object is noticed.
- 29) The engagement holder or his employee should be in prescribed dress code with display of identity card while on duty. The identity card shall be issued from GMC after police verification. The workmen shall possess good behavior and should be polite while dealing with the owners of the vehicles.
- 30)Two wheelers with baggage should not be allowed to enter the parking place. Ensuring the same will be the duty of lessee and his agents.
- 31) The engagement holder is responsible for any theft/burglary of the vehicle once it is parked in a parking lot.
- 32) The lessee or his agent shall issue the parking receipt as soon as vehicle enters and is parked in the parking lot so that there is effective supervision of the vehicle. The receipt should be 'CANCELLED' by a cross when the vehicle is taken away.
- 33)The lessee shall adhere to any new instructions issued from time to time by the GMC as to the mode and methodology of parking fee collection and strictly follow the procedures prescribed therein.
- 34) The violation of any of the terms and conditions shall lead to termination of the lease agreement with the lessee.

- 4) If any bids submitted for settlement of the parking places under the Guwahati Municipal Corporation appear to be unreasonably high, reckless and highly disproportionate, if there is probability or apprehension of indulgence of extortion activities to realize such settled value the Commissioner GMC shall have every right to reject such offer.
- 5) The bidders should quote in figure as well as in words the rate and amount tendered by them. All corrections in the tender papers shall be attested by the dated initials of the bidders.
- 6) Where the rate quoted by the bidder in figures and in words do not tally, the amount written in words shall be taken as correct. The rate should be quoted for 09 (nine) months only.
- 7) The distances shown in the list of city parking places are approximate. If any City Bus stand falls within the parking slot 15 meters from both sides of city bus stand shall be excluded from parking of vehicles. In case of notified Auto Stand, the net auto stand area has to be excluded from parking of vehicles by the lessee. Bidders are requested to make physical survey of the parking places for their satisfaction before bidding.

8) Selection Process:

a) After scrutiny of the documents submitted by the bidders, the successful bidder will be intimated by giving a LoI (Letter of Intent) to him/her.

- b) After getting the **LoI** the selected bidder has to deposit 50% of the settled value as advance deposit within 48 hrs. from the receipt date.
- c) After receiving the above mentioned documents the bidder will be given a final order granting the lease of the parking. The balance 50% amount of settled value will have to be deposited by the bidder in 4 (four) equal installments the due date of which will be intimated in the aforesaid order.
- d) The selected bidder has to execute an agreement with the Commissioner, GMC within 10 (ten) days from the issue date of the final order granting the lease of the parking otherwise the lease shall be invalid.
- e) On default, the bidder will be disqualified and his earnest money so deposited in the prescribed form shall be forfeited. In such a situation, the next highest bidder shall stand qualified for the next offer.
- f) If the lessee/bidder fails to pay any of the installments within the stipulated time as mentioned in the order granting lease of parking, 10% penal interest shall be charged against any such delayed payments. Further, if the lessee fails to pay installment within 3 (three) months, the lease would be terminated forthwith and the parking place will be taken over by GMC and earnest money and the advance payment so deposited shall be forfeited declaring the lessee as defaulter. Defaulting lessee shall be liable to be blacklisted and shall be prohibited from participating in any tender process of the Corporation in future. Any arrear due to the Corporation by the lessee, shall be recovered either under the provisions of the Chapter XX of the Guwahati Municipal Corporation Act, 1971 or under the Bengal Public demand recovery Act, 1913, or as the Commissioner may decide in this behalf.
- 9) On acceptance of any tender, the bidder shall be liable to pay any taxes as per Contract Act and the Corporation will not entertain any such claim whatsoever in this respect. The rate quoted by the bidder should be in the following format:

Bid Value	GST(18 % of bid value)	Total Bid value including GST

- 10) No concession regarding Bharat bandh or Assam bandh or local bandh or any such thing except for any pandemic situation will be entertained.
- 11) In case of any delay for issuance of the final lease order, the adjustment will be made considering the issue date of the lease order as lease starting date. The total payable amount will be calculated starting from the issue date of the lease order up to the end date of the lease and this adjustment will be made during the last installment of the lease.
- 12) No person, firm, co-operative society or company will be allowed to participate in the tender process who/which was either convicted by any Court of law at any point of time or blacklisted by the Corporation in connection with any contract or held irresponsible in any, matters of the Corporation. The previous conduct or records of any such bidder, if any shall work out the basis for such purpose.
- 13) Any bidder who withdraws his tender after submission of the tender but before opening of the same for such modifications which are not acceptable to GMC, then the Commissioner, GMC without prejudice to any other right or remedy, will be at liberty to forfeit earnest money.
- 14)It would be obligatory on the part of the bidders to sign the tender documents on all relevant pages and for all component parts thereof.

- 15)The selected bidder shall collect caps and jackets from GMC on payment of Rs. 500/- per head in addition to 50% security deposit within 48 hrs. of the offer letter. The actual amount can be more or less depending upon the actual cost of products.
- 16) The settled bidder, to be later named as lessee, shall be entitled to levy parking fee as per the rate prescribed below and all collections are to be made through Android POS based ticketing system.

- 17)At the time of parking, a ticket for parking shall be issued to the owner / driver of the vehicle by the lessee where entry time and exit time of the vehicle should be clearly mentioned. The collectors present at the parking place should maintain the social distance as mandated by COVID 19 guidelines, wear mask, hand gloves and maintain proper hygienic condition at the parking slot, as a precautionary measure against the pandemic situation.
- 18) Excess demand of parking fee beyond the prescribed rate is strictly prohibited. Any complaint of charging excess money shall lead to institution of Criminal proceedings under law against the settled bidders and his agents and will result in cancellation of lease without assigning any reason thereof.
- 19) The lessee shall maintain a register wherein registration no. of the vehicle and name of the person driving the vehicle shall be recorded.
- 20) The lessee shall use Digital Camera (CCTV cameras for flyovers and must check vehicles on entry with under vehicle search mirror and metal detector), and other necessary equipments required for implementation of this contract and take photographs of the persons driving the vehicle and keep records with him at the time of parking, date wise for at least last 7 (seven) days for verification by authorities, else action will be initiated as per law and tender will be cancelled forthwith.
- 21) The lessee shall maintain proper lighting of the entire parking space under the flyover in order to prevent any untoward incident.
- 22) The lessee shall maintain a register wherein name of the hawker, registration no. of the vehicle and name of the person driving the vehicle shall be recorded.
- 23) The lessee shall use Digital Camera and other necessary equipments required for implementation of this contract and take photographs of the hawkers, persons driving the vehicle and keep records with him at the time of entry, date wise for at least last 7 (seven) days for verification by authorities, else action will be initiated as per law and tender will be cancelled forthwith.
- 24) The lessee must execute an agreement with the Commissioner, GMC before the commencement of the work otherwise the lease shall be invalid.
- 25) The period of fee collection shall be confined from **5 A.M.** to **10 P.M.** only. The lessee shall not operate any fee collection outside these hours.
- 26) Entry fees should not be levied on Govt, and GMC vehicles while on duty.

- 27) The Commissioner, GMC reserves the right to disqualify any tender/ terminate the lease without assigning any reason thereof.
- 28) In case of any eventualities, engagement holder is bound to produce related records, failing which he will invite punitive action as per law.
- 29) Municipal bins in and around the bus terminus are to be monitored closely by the lessee & the lessee shall inform the concerned NGO/Executive Engineer, GMC in case the bins are full.
- 30) The engagement holder or his employee should keep close liaison with concerned police stations and inform immediately if any suspicious object is noticed.
- 31) The engagement holder or his employee should be in prescribed dress code with display of identity card while on duty. The identity card shall be issued from GMC after police verification. The workmen shall possess good behavior and should be polite while dealing hawkers, owners/drivers of the vehicles.
- 32) The lessee or his agent shall issue the fee receipt to the Hawkers and the vehicles as soon as it enters in the bus terminus so that there is effective supervision can be made. The receipt should be 'CANCELLED' by a cross when vehicle is taken away.
- 33) The lessee shall adhere to any new instructions issued from time to time by the GMC as to the mode and methodology of fee collection and strictly follow the procedures prescribed therein.
- 34) The bidder having previous experience of similar work amounting to singular work order of 40 (forty) lakhs or above will be given preference as per relevant Acts /Guidelines of GMC.
- 35) The violation of any of the terms and conditions shall lead to termination of the lease agreement with the lessee.

36) If the highest bidder fails to take lease of the parking place then the parking will be allotted to the next highest bidder and earnest money deposited by the highest bidder shall be forfeited.
