

 - The Bid Document fee, as mentioned above, should be paid either in the form of Demand Draft issued by any Nationalized/Scheduled Bank or pay directly by depositing Rs. 10,000.00 at Cash Branch, GMC, Panbazar, Guwahati-1 and money receipt have to be submit along with the Bid document.
 - Bid securities in the form of TDR/FDR from a nationalized/scheduled bank.
- A Hard copy of the technical bid including document fee along with bid security submitted online on or before 03/03/2020 up to 14.00 hours for evaluation purpose. For any discrepancy between the online bid and the hard copy of the bid, the online bid will be governed and will be considered for evaluation.
- Bidders are advised to scan their Papers at 100dpi (in black & white mode) in 'PDF' format for multiple pages with maximum file size of 25MB. If numbers of pages exceed, the bidders are advised to create multiple files and upload the same in "Upload additional document" stage.


