The meeting of the Committee, chaired by the Addl. Commissioner, GMC is convened on 29.03.2023 in presence of the members as detailed below. The meeting was convened in order to evaluate Technical Bids received for – “GGR/380/2022/12; DATED- 15th March 2023.

The committee noted that current bidding procedure is a Re-tender and is well published in two newspapers of wide circulation (Janasanyog/CF/4875/22 vide The Assam Tribune).

The Records of Bid Opening in presence of Bidders is maintained as **Appendix-I**.

The following bids were received-

1. M/s Maya Enterprise.
2. M/s Dipak Sarma
3. M/s P.S Enterprise
4. M/s Vidur's
5. M/s D.N Enterprise
6. M/s E2E Engineering Solutions

The committee evaluated the Technical bids received and details of technical evaluation is attached as **Appendix-II** to this minutes.






The Abstract and Recommendation of the Committee are-

1. Bidder M/s Maya Enterprise has submitted financial bid in its technical bid and as per bidding terms of Two envelope bidding, the bid is rejected.
2. The committee noted that bidders viz. M/s Maya Enterprise, M/s Dipak Sarma, M/s Vidur's, M/s D.N Enterprise & M/s E2E Engineering Solutions have not submitted/not met critical requirements of the bidding terms as detailed and are marked in Appendix-II.
3. The committee noted that, only one bidder viz. M/s P.S Enterprise is substantially responsive in line with point 2 above.
4. The committee also analysed that all the other bidders did not meet multiple parameters and committee could not judge the parameters such as – Experience requirement, Turnover requirement & Non-declaration of Forms/Annex I (in Non-judicial stamp paper) as immaterial in line with Rule 23 Sub-rule 15 of the APPR 2020.
5. The committee in reference to Rule 23, Sub-rule 20 (ii) of the APPR 2020 analyzed and recorded as-
 - a. The bid was published multiple times previously and was cancelled due to lack of competition. The requirement has now become the essence to meet Solid Waste management requirement for the city. The procurement also being in parallel rate contracting mode only to meet the repetitive and justified requirements that may be discovered subsequently.

- b. This was a re-tended and wide requisite publication through newspaper (Assam Tribune and one regional assamese) was done- **Appendix-III**.
 - c. SPPP portal publication was also done in addition to website publication. Refer **Appendix IV** as SPPP publication record.
 - d. The sole responsive bidder is substantially responsive and documentary evidences provided.
6. The committee in order to ensure compliance to Sub-rule 20 (ii) (b) and to check for reasonableness of the price quoted by M/s P.S Enterprise, recommended opening of financial bid of the bidder. The committee shall check for the price quoted for the Product and a comparison with previous procurement cost of the product undertaken by GMC shall be done subsequently.

Meeting ended with vote of thanks from the chair.
