- 1. The Quotations must be addressed to the Commissioner, GMC in the Bidder's letter pad.
- 2. Name and Address of the Bidder should be clearly mentioned.
- 3. Intending Bidder should mention their PAN No. and GST No. etc. submitting self-attested photocopies of the same thereof. Else it will be a cause to disqualify the quotation. Firms/agency/company registered as MSME can submit Udyog Aadhaar.
- 4. All proposals submitted in response to the NIQ shall be accompanied by a Bid Security of Rs. 2000.00 (Rs Two Thousand) only in the form of Demand Draft in favor of "The Commissioner, Guwahati Municipal Corporation" payable at Guwahati. The Bid security of the unsuccessful bidders would be returned after the acceptance of the letter of Intent to the successful bidder. The same of the successful bidder will be discharged at the time of signing of the agreement.
- 5. Bidder has to quote the rate as per prescribed format in Annexure II.
- 6. The Quotations will be valid for 24 (Twenty-Four) months from the last date of submission and the contract may be renewed based on the satisfactory performance which will be decided by the GMC.
- 7. The Envelope should be super scribed with Quotation for "SMS gateway services for G.M.C.".
- 8. The result after scrutiny of quotation will be communicated to Qualified Bidder.
- 9. Taxes will be deducted from the payment from the selected Bidder.
- 10. The Bidder shall be responsible for undertaking all civil/electrical works related to the work.
- 11. Time of completion of the entire work will be 15 (fifteen) days from the date of issuance of workorder. In case of any failure to complete the entire work within the stipulated time, a penalty @ 5000 per day will be imposed.
- 12. The service shall be provided 24 hours & 7 days in week.
- 13. As and when required by GMC, the selected Bidder will have to provide onsite support to GMC stuff.
- 14. Experience of similar projects/ or state government projects -minimum 3 purchase orders to be submitted in the state of Assam. Proof of such experience to be attached.
