The meeting of the Committee, chaired by the Addl. Commissioner, GMC is convened on 28.03.2023 in presence of the members as detailed below.

The meeting was convened to evaluate Single envelope/single cover bids received for "Supply of Unskilled Labourers". The bid was published through Janasanyog/CF/4847/22 Dt. 15/03/2023.

A total of 10 bids were received viz.

2. M/s PS enterprise
3. M/s Vibe enterprise
4. M/s Manabendra Kr. Sharma
5. M/s Azahar Ali
6. M/s One to Ten solutions
7. M/s Pallabi Sharma
8. M/s Brahma Traders
9. M/s Creative power enterprise
10. M/s Protection Security Solution

It was found by the committee that **M/s Protection Security Solution** quoting an amount of Rs. 456.09/- (Inclusive of taxes, duties, levies and all allied costs as per bidding terms) is the lowest bidder. But subsequent to straightway evaluation and prior to finalization of minutes, the L1 bidder (apparent) has submitted letter of withdrawing (Refer Appendix II attached herewith) which is self-explanatory. The committee recorded that the bidders viz. **M/s Brahma Traders, M/s DN enterprise & M/s Creative power enterprise** does not have the specific experience of supplying unskilled labours/manpower as per Cl-2.2.4 of the issued bidding document and has submitted work orders of allied construction works or machinery

hiring works. Further, M/s M/s Brahma Traders has not submitted Form-1 in Non-judicial stamp paper.

The committee considering the facts, recommended –







1. M/s Pallabi Sharma stands as the Lowest and substantially responsive bidder.
2. The bid being in parallel rate contracting mode as already defined in the bidding document, adherence to Rule 24 (l) (1) (iv) of APPR 2020 shall be ensured for parallel contracting.
