INTRODUCTION

- 1.1 Guwahati Municipal Corporation plans to install Four numbers of trolley mounted bio-toilets and one Tractor under PPP Mode in order to provide public utilities to the citizens.
- 1.2 This Request for Proposal Document is issued to Reputed Trolley Mounted Toilet Supplier/ manufacturer or Class 'A' Contractors of GMC and APWD or NGO's or SafaiKarmachari Association or organization interested in undertaking Supply and Installation of trolley mounted bio-toilets and Tractor to Guwahati Municipal Corporation and Maintain it for a period of 7(Seven) years.
- 1.3 Request for Proposal (RfP) is sought from Reputed Trolley Mounted Toilet Supplier/ manufacturer or Class 'A' Contractors of GMC and APWD or NGO's or Safai Karmachari Association or organization who are interested in bidding for the Project either individually or as a consortium of such firms. The bidder would be required to Supply and Installation the trolley mounted bio-toilets and Tractor to Guwahati Municipal Corporation as per the specifications mentioned in the RFP below.

- 2.2 GMC intends to procure trolley mounted bio-toilets and Tractor, through a phased approach, with proposed user and environment friendly designed toilets as per the specifications mentioned below.

3 IMPLEMENTATION STRATEGY

3.1 The reputed firms/manufacturers/institutions shall carry out the services as per the technical specifications, performance standards and guidelines given as part of the Contract agreement. The Supply and Installation should be completed on or before, within which the reputed firms/manufacturers will Supply and Installation all trolley mounted bio- toilets as per the requirements, technical specifications and standards as mentioned in the RFP to Guwahati Municipal Corporation.

4 FEATURES AND SPECIFICATIONS

- 4.1 The Trolley mounted Units should be 4nos Indian style squat. The toilet cabins should be of double layer ACP (Aluminum composite panel) with rust free anti skid floor on MS frame.
- 4.2 The Bio Toilets shall have DRDO developed Bio Digester tank.
- 4.3 The trolley mounted bio-toilets should have a bio-digester of minimum 50 user capacity.

- 4.4 The trolley mounted bio-toilets must have provision for lighting and water Supply and Installation from the overhead tank.
- 4.5 There must be provision of ramps for the differently abled users.
- 4.6 The plumbing and the electrical work must be concealed and must use the fittings of reputed brands only.
- 4.7 There must be a provision for the installation of a power generator in the future.
- 4.8 Space must be provided for a storage closet.
- 4.9 There must be one wash basin with adequate water supply.
- 4.10 The design must be aesthetically attractive and provision must be there for illuminating via external power source and generator externally and internally with LED lights, so that no inconvenience is caused during night.

5 <u>DETAILED SCOPE OF WORK</u>

- 5.1 Supply and Installation of trolley mounted bio-toilets as per the specifications provided by Guwahati Municipal Corporation in Clause no. 4 above.
- 5.2 Supply and Installation and installation to be completed on time or before without fail.
- 5.3 The agency has to maintain (including installation, cleaning and feeding of the inoculum) the trolley mounted bio-toilets during the Contract period.
- 5.4 The Bidder shall maintain the Bio Toilets for a period of 7(seven) years.
- 5.5 The toilets should be able to withstand the Guwahati climate.

- 5.8 The trolley must be provided with a storage water tank of minimum 300 litres and a bio-digester tank with 50/day user capacity.
- 5.9 The Bio- Digester tank shall be of patented DRDO technology.
- 5.10 There must be arrangement of LED lighting at the trolley mounted bio-toilets.
- 5.11 The trolley mounted bio-toilets must be easily accessible for differently abled people and senior citizens.
- 5.12 Water for closets shall be operated by flushing only.
- 5.13 The bidder must provide warranty against any manufacturing defect for a period of one year from the date of delivery.
- 5.14The bidder shall submit the detailed drawings with dimensions and material specification (plans, elevations, sections and a colored 3D view/photograph) of the trolley mounted bio-toilet as per the specifications mentioned by GMC.
- 5.15 The Bidder shall be allowed to install Hoardings and generate revenue within the Trolley but bidder has to pay Hoarding Taxes.
- 5.16 The Bidder shall maintain the Trolley mounted Bio Toilets throughout the Contract period.
- 5.17 The Bidder shall be allowed to collect user charge that is Rs.10/- per user of the Toilet.
- 5.18 The period of contract shall be of 7(Seven) years, after the expiry of the contract period trolley mounted Bio-Toilet and tractor shall be the sole property of Guwahati Municipal Corporation.
