#### A) Preparation of Bid Documents:

Bids will be prepared in two categories:

- 1. Technical Bid
- 2. Financial Bid

#### **B)** Eligibility Criteria of the Bidder:

- 1. Bidders are required to submit a non-refundable document processing fee of Rs. **1000.00** (One Thousand Only) in the form of demand draft/banker's cheque drawn from a nationalized/scheduled bank in favour of the **Commissioner**, **Guwahati Municipal Corporation**. This demand draft should be part of the RfP. The bidder can also submit the document processing fee in cash at cash counter of Guwahati Municipal Corporation. In that case, the original copy of cash receipt of document processing fee from the office of Guwahati Municipal Corporation, Panbazar along with the other necessary documents (hard copy) should be submitted.
- 2. The Bidder shall have to submit the proof of payment of EMD **Rs. 2,00,000.00** (Rupees Two Lakh Only) only in the form of demand draft/FDR/banker's cheque to

be pledged in favour of the "**Commissioner,Guwahati Municipal Corporation**" from any Nationalized/Scheduled Bank payable at Guwahati.

- 3. The bidder must be a Company/ Firm/Advertising Agency, registered under the companies act or any other government authority based in Assam and must be in operation for minimum 7 (seven) years.
- 4. The bidder must have achieved an average annual financial turnover of Rs. 800.00 Lakh (Eight Hundred Lakh Only) of preceding 3 (Three) years. (*To calculate the average turnover, the total turnover of last 3(three) year shall be divided by 3* (*three*).Documentary evidence should be enclosed. Multiplying factors for the last 3 years will be considered if any as per standard SBD.

# 5. The bidder will bid annually for each package and the additional rental value for GMC will be bidding parameter.

6. At the time of payment deposit for GMC, the bidder should pay both advertisement tax and additional rental value.

#### C) Technical bid envelop will contain:

The bidder should fill up the Annexure – II and furnish the copy of following documents in the technical bid envelope along with their proposals.

- i) Pan Card of the Firm/Company
- ii) Registration Certificate Registration under Company's Registration Act ( in case of company) /Firm Registration under Govt. of Assam( in case of firm)
- iii) Up to date Trade License
- iv) GST Registration Certificate.
- v) Financial Turn over of last 3 (three) Financial Year.
- vi) Self certification (Annexure III) that his/her Firm is not under a declaration of Ineligibility/Blacklisting for corrupt and fraudulent practices or for any other causes by Govt. of Assam and or Govt. of India or any other State.
- vii) If bidder is found to be defaulter in GMC advertisement tax, the bidder will be rejected.

All Bid Documents should be self-attested by the Bidder concerned. Joint ventures or consortium will not be allowed to participate in the tender process. The technical proposal shall not include any financial information. A technical proposal containing financial information shall be declared non responsive and liable to be cancelled.

#### D) Financial bid envelop will contain:

The bidder should fill up Annexure-IV and submit the financial bid separately in separate envelopes. The bidder should bid based on the bus shelter details as given in **Table 1**.

The intending bidders are required to inspect the sites as mentioned in the above list before submission of their bids.

The packages of all the Bus Queue Shelters are created with the motive of serving the public and also generating revenue for its maintenance. The locations are categorised into A & B, whereas A comprises of locations which have more footfall and B have less footfall. This is done because frequency of footfall determines the rental cost of Bus Queue Shelter. So, keeping in view the above reasons four locations comprising of two A category and two B category are clubbed under each package to give equal opportunities to all the parties.

E) The bidder has to bid the additional rental value for GMC for each package as per Annexure IV.

The bidder quoting the Highest amount (H1) for the work will be declared the successful bidder and will be issued the LoI.

#### F) Submission of Bid

The bidder should submit technical bid (Annexure-II) and financial bid (Annexure-IV) separately in two separate envelopes along with relevant documents and demand drafts for document processing fee and EMD. The envelopes for technical bid (Annexure-II) and financial bid (Annexure-IV), the Demand Drafts, Covering Letter (Annexure-I) and a copy of the bid document duly Seal and signed by the authorized signatory of the bidder in each page are to be put together in an outer envelope which is to be submitted on or before the last date of submission to the address : Commissioner, Guwahati Municipal Corporation, Panbazar, Guwahati 781001. The outer envelope should be marked with "Leasing of Bus Queue Shelters under Guwahati Municipal Corporation Area for revenue generation and its periodic maintenance for the period of 5 years". Incomplete bid document, copy of this bid document and bid documents received without the Seal and Signed in each page, drafts for document processing fees and EMD or after due date and time will be summarily rejected.

#### G) Scope of Work

- 1) The Bidder shall install Glow sign advertisement panel.
- The size of Glowsign advertisement panel for front it will be 32x4 sq.ft., for Inside panel it will be 24x4 Sq. Ft., and for Two numbers of side panel it will be of size 7x4 Sq. Ft.
- 3) The bidder shall guarantee of the structural stability of the advertisement panel.
- 4) The bidder shall rectify in case of any default arises in the advertisement panel at the earliest.
- 5) The bidder shall guarantee of all the safety measures to be incorporated in the advertisement panel.
- 6) The Bidder or its representative shall personally visit Bus Q Shelter to keep the Bus Q shelter neat and clean.
- 7) The entire cost of Installation of Glow sign Advertisement panel shall be borne by the selected bidderwithout any financial contribution from GMC.

- 8) The bidder shall Operate and Maintain bus Q shelter for a period of 5( Five) years.
- 9) The work allotted shall not be used by the bidder for purpose other than for which it is allowed.
- 10) The Bidder shall arrange for all the commodities required for the proper functioning and maintenance of the bus Q shelter.
- 11) That the Bidder should make available Complaint/Suggestion Box within the premises.
- 12) The Authority shall not be responsible for untoward incidence, if occurred due to structural fault of the Advertisement panel. The bidder would be responsible for any civil/criminal proceedings arising out of such incidence and for damage caused to life and property thereof.

#### H) Performance Bank Guarantee

The performance security will be 10% of total proposed payment and it will be the Performance Bank Guarantee of the selected bidder. In case of failing to meet the target, the Performance Bank Guarantee will be forfeited.

#### I) Right to amend document

GMC reserves the right to modify the specifications at any time prior to the last date of submission of bid which will be uploaded in the website of GMC only from time to time, notto be floated in any newspaper. In order to provide prospective bidders reasonable time to respond to the modifications, GMC may, at its sole discretion, extend the last date for submission of bids.

#### J) Right to accept or reject bids

GMC reserves the right to accept or reject any or all bids without incurring any liability or obligation. The decision of GMC in this regard willbe final.

#### **K)** Termination of Contract

GMC reserves the right to terminate the selected bidder at any stage in case of breach of any of the guideline and terms & conditions by the selected bidder or in case their performance is not found satisfactory. GMC shall be entitled to terminate the selected bidder in case of any neglect or lapse on the part of the selected bidder.

The bidder should deposit the proposed annual payment in advance before starting the work.

In case the bidder is found to be defaulter in advance payment deposit, a penalty of 20% will be imposed.

In case the default is more than 2 months, the agreement of the bidder will be terminated with forfeit.
